### National Training of Trainers Preparing AYUSH Doctors and Practitioners for COVID-19 Preparedness, Response and Containment

#### Objectives:

At the end of the Training of Trainers participants will be able to:

1. Use the prepared AYUSH Doctors and Practitioners training package to conduct on-line trainings at state with district and block levels.
2. Understand the feedback and support mechanisms to be used during the online training.
3. Prepare and formalize the plan for cascading the training at the State with District and Block levels

#### Training Package comprises of the presentation to be used for training of AYUSH Doctors and Practitioners:

- Enhancing uptake of response and control public health measures (safe behaviours including social distancing and early self-reporting if symptoms develop) and tracking and addressing of rumors and misinformation.
- Supporting community surveillance process (Early identification, contact tracking and reporting).
- Strengthening community linkages with public health services on prevention and control (home quarantine, homecare, PSS, stigma and discrimination) including community/family support systems).
- Protection of frontline workers from acquiring COVID-19.
