Our hospital got an initial permission letter on 6<sup>th</sup> January 2005. And currently our hospital has a permission of 268 beds under The Bombay Nursing Home Act.1949. Its validity is up to 31.03.2027. Our hospital is a Teaching hospital & for the academic requirements. We increased the 06 beds from 08.04.2026. As per NCISM email dated 07.04.2026. Hence currently the total bed strength of our hospital has become 274 beds.
