C) Qualifications and Experience for Teaching Staff for UG Teachers:

(Ref: NCISM UG Notification Dated 01/05/2024, & Academic Council Resolution No.129/2016 dated 19/12/2016)

(a) Essential qualification. -

- (i) a Bachelor Degree in Ayurveda from a university or its equivalent as recognised by the Central Council of Indian Medicine or National Commission for Indian System of Medicine under the Act;
 - (ii) a post-graduate qualification in Ayurveda in the concerned subject or specialty from a university recognised by Central Council of Indian Medicine or National Commission for Indian System of Medicine under the Act;
 - (iii) a valid registration with the concerned State Board or Council where he is employed or a valid Central or National Registration Certificate issued by Central Council of Indian Medicine or National Commission for Indian System of Medicine;
- “This is not applicable for teachers of non-medical qualifications,”
- (iv) Qualification for teacher of Sanskrit shall be a post-graduate degree in Sanskrit recognised by the University Grants Commission and a candidate with Bachelor of Ayurvedic Medicine and Surgery qualification at under graduate level and M.A. (Regular) in Sanskrit shall be given priority.
 - (v) The teachers having Bachelor Degree in Ayurveda medicine and having post-graduation in relevant modern science disciplines as referred to clause (h) of section 2 of Act, and as mentioned in section 10 of these regulations and having University Grants Commission/Council of Scientific and Industrial Research/Indian Council of Medical Research National Eligibility Test qualification shall be eligible to appoint without qualifying the National Teachers Eligibility Test.

(b) Experience.- (i) For post of Professor.-

- (A) Ten years of teaching experience as regular teacher in the concerned subject or five years teaching experience as Associate Professor (Reader) on regular basis in the concerned subject; or
- (B) Ten years research experience as fulltime researcher (after possessing Post-graduate qualification in the concerned subject) in Research Councils of Central Government or State Government or Union territory or University or National Institution or National Accreditation Board for Testing and Calibration Laboratories (NABL) accredited Research Laboratory or ten years of experience in regular service (after possessing Post-graduate qualification in the concerned subject) in Central Government Health Services or State Government Health services, Ministry of Ayush or ten years of experience (after possessing Post-graduate qualification in the concerned subject) as Assistant Registrar or Registrar in Central Council of Indian Medicine having qualified National Teachers Eligibility Test from the date it is operational and with any one of the following three criteria, namely:- (i) Minimum of five research articles published in index journals (UGC-CARE, PubMed, Web of Science, Science Citation Index, SCOPUS); or
- (ii) Minimum of three research articles published in index journals (UGC-CARE, PubMed, Web of Science, Science Citation Index, SCOPUS) and one Published book or Manual relevant to Ayurveda; or
- (iii) Investigator for any major research project (duration of the project three years and above as per the sanctioned letter); and (iv) Having post-graduate qualification in concerned subject except in the subjects or specialty of Shalya, Shalakya and Stree Rog evam Prasuti tantra: provided that the in-service candidate shall have completed his post-graduation in concerned subject before the completion of forty-five years of his age.



(ii) For post of Associate Professor.-

- (A) Five years of teaching experience as regular teacher in the concerned subject; or
(B) Five years of research experience as fulltime researcher (after possessing Post-graduate qualification in the concerned subject) in Research Councils of Central Government or State Government or Union territory or University or National Institutions or National Accreditation Board for Testing and Calibration Laboratories (NABL) accredited Research Laboratories or five years of experience in regular service (after possessing Post-graduate qualification in the concerned subject) in Central Government Health Services or State Government Health services, Ministry of Ayush or five years of experience (after possessing Post-graduate qualification in the concerned subject) as Assistant Registrar or Registrar in Central Council of Indian Medicine having qualified National Teachers Eligibility Test from the date it is operational and with any one of the following three criteria, namely:- (i) minimum of three research articles published in indexed journals (UGC-CARE, PubMed, Web of Science, Science Citation Index, Scopus); or
(ii) Minimum of one research article published in indexed journals (UGC-CARE, PubMed, Web of Science, Science Citation Index, Scopus) and one Published book or Manual relevant to Ayurveda; or
(iii) Investigator for any major research project (duration of the project three years and above as per the sanctioned letter) or minor research project (duration of the project less than three years as per the sanctioned letter); and
(iv) Having post-graduate qualification in concerned subject except in the subjects or specialty of Shalya, Shalakya and Stree Rog evam Prasuti tantra: Provided that the in-service candidate shall have completed his post-graduation in concerned subject before the completion of forty-five years of his age.

(iii) For post of Assistant Professor.- No teaching experience shall be required but, the age shall not exceed forty-five years at the time of first appointment.

D) Qualifications and Experience for Teaching Staff for PG Teachers:

(Ref: NCISM P.G. Notification dated 01 October 2024 & Academic Council Resolution No.129/2016 dated 19/12/2016)

- (1) Possessing Postgraduate Degree in the concerned specialty or subject obtained from a recognized University, and included in Second Schedule of Indian Medicine Central Council Act, 1970 (48 of 1970) or recognized under section 35 and section 36 of the Act.
(2) A valid registration with concerned State Board or Council or a valid Central or National registration certificate issued by the Board of Ethics and Registration for Indian System of Medicine; however, the registration certificate is not applicable for the teachers of non-medical qualifications.
(3) **For the post of Professor.** - (a) teacher having ten years of regular teaching experience in Postgraduate teaching in the concerned subject or five years of teaching experience in Postgraduate teaching as Associate Professor on regular basis in the concerned subject; or
(b) total ten years of research experience as full-time researcher after possessing Postgraduate Degree qualification in the concerned subject on regular appointment in Research Institutions or Councils of Central Government or State Government or Union Territory Administration or University or National institutes or Research Laboratories having accreditation by National Accreditation Board for Testing and Calibration Laboratories (NABL), provided on fulfilling the below determined criteria:
(i) qualified in the National Teachers Eligibility Test conducted by the Commission; and
(ii) minimum five research papers published in indexed journals (indexed in UGC-CARE, PubMed, Web of Science, Science Citation Index, Scopus); or two published books or manuals relevant to Ayurveda; or
(iii) investigator for any major research project with a duration of the project three years and above.
(4) **for the post of Associate Professor:** (a) total teaching experience of five years as regular teacher in Postgraduate teaching in the concerned subject; or
(b) total five years of research experience as full-time researcher after possessing Postgraduate Degree qualification in the concerned subject on regular appointment in Research Institutions or



Councils of Central Government or State Government or Union Territory Administration or University or National institutes or Research Laboratories having accreditation by National Accreditation Board for Testing and Calibration Laboratories (NABL), provided on fulfilling the below determined criteria:

- (i) qualified in the National Teachers Eligibility Test conducted by the Commission; and
 - (ii) minimum three research papers published in indexed journals (indexed in UGC-CARE, PubMed, Web of Science, Science Citation Index, Scopus); or one published book or manual relevant to Ayurveda; or
 - (iii) investigator for any research project with a duration of the project not less than three years.
- (5) Research experience shall not be considered for appointment as a teaching faculty in the Postgraduate departments of Shalya Tantra, Shalakya -Netra, Shalakya- Karna Nasa and Mukha; and Streeroga – Pasuti Tantra.
- (6) For holding the post of Assistant Professor a person shall have been qualified in the National Teachers Eligibility Test conducted by the Commission.
- (7) Qualifying in National Teachers Eligibility Test is mandatory irrespective of cadre who would like to enter in to Teaching profession in Ayurveda.
- (8) The actual research experience acquired during a regular full-time Doctor of Philosophy Programme, from the date of joining to the date of submission of the thesis and not more than three years shall be considered as teaching experience and Ph.D. seat allotment letter, proof of joining to full-time Ph.D. Programme and proof of submission of thesis to the University shall be considered as evidence in this regard.
- (9) Department of Integrative Health and Translational Research, there shall be a minimum of one full time regular Professor having Postgraduate Degree holder in Swasthavritta and Yoga preferably with Ph.D. and a biochemist, microbiologist, pharmacologist and Biostatistician shall be appointed on part time basis.
- (10) (a) Temporary appointments or contractual appointments shall not be allowed. However, in case of Government Institutions contractual appointments may be allowed with following conditions, namely:--
- (i) shall be as stop gap arrangement;
 - (ii) shall not be more than two years for a particular post in particular department;
 - (iii) shall be qualified in National Teachers Eligibility test.
- (b) temporary promotion or promotion without salary benefits in accordance to respective cadre shall not be allowed.
- (a) shall have been attended, the capacity building Programme on Educational Administration conducted by the Commission or any other equivalent Programme approved by the Commission or shall attend within six months period from the date of joining as head of the institution;
- (b) the successful completion of the orientation Programme on educational administration is a mandatory requirement for holding the post of the head of the institution;
- (c) failing which, the incumbent shall not be considered for the post of head of the institution by MARBISM.

G) GENERAL NOTES :

- 1) Candidates applying for reserve category post(s) should submit caste certificate & caste validity certificate and also recent non-creamy layer certificate, wherever applicable.
- 2) The benefits of reservation shall be admissible to the back ward class /category candidates who are domiciled in the state of Maharashtra only.
- 3) Age Limit & Educational Qualifications shall be considered up-to-day of the interview.
- 4) The decision taken by MUHS authorities regarding essential qualifications and experience shall be applicable, from time to time.
- 5) Qualified teachers above the age of 60 years will be considered for one - one year, as per respective council's norms for the Private/ Government / Aided College.
